Duties of the Estate Executor During the Probate Process

• <u>Reads the Will</u>

The executor reviews the will, expedites burial instructions, and meets with family members and interested parties to provide guidance. They also consult with the attorney who drafted the will and those familiar with the deceased's financial affairs.

• <u>Safeguards the Estate's Assets</u>


Immediate protective measures are taken to secure assets before formal appointment as executor. This includes ensuring proper insurance coverage, protecting real and personal property, and overseeing any ongoing business interests.

• <u>Assembles and Inventories All Assets</u>

The executor examines financial records, books, and files of the deceased to create an inventory of assets.

• <u>Petitions the Court for Probate of the Will</u>

The executor works with an attorney to obtain proof of heirship, locate witnesses, and petition the court for probate. They notify financial institutions, collect life insurance proceeds, secure tax waivers, and inventory valuable assets. Additionally, they manage real estate holdings, oversee leases and mortgages, and ensure business interests are properly handled.



cont...Duties of the Estate Executor

• <u>Procures Appraisals of All Assets</u>

The executor arranges for professional appraisals to determine the value of assets as of the date of death, which is essential for tax and distribution purposes.

• <u>Administers the Estate</u>


Following the will's directives and probate law, the executor determines the best course of action for valuable collections, real estate, and business interests. They assess market conditions, decide on asset sales, and ensure enough cash is available to cover taxes, debts, and expenses while preserving the estate's value for distribution.

• <u>Makes All Tax Returns</u>

The executor files all necessary federal and state tax returns, including inheritance, estate, and income taxes. They also handle tax obligations for the year prior to death, secure waivers for property transfers, and ensure compliance with tax authorities.

• <u>Settles All Proper Claims</u>

Creditors are notified, and the executor reviews and settles valid claims against the estate. They also resist improper claims and ensure all tax liabilities are paid before distributing assets to heirs.



cont...Duties of the Estate Executor

• <u>Distributes the Probate Estate</u>

After settling debts and obtaining court approval, the executor prepares final accounting documents and distributes the remaining estate according to the will and court orders.

• <u>Obtains Final Discharge</u>

Once all obligations are met and assets are distributed, the executor files for final discharge, officially concluding their role in managing the estate.



The Probate Timeline

Prepare and File Petition for Probate	1-2 months
Court hearing on the Petition for Probate	2-3 months
The following are issued: Letters of Administration, Orders for Probate, Duties and Liabilities, Issue Bond (if ordered), & **Letters of Testimentary **	2-4 months (if not contested)
Notice to Creditors	2-4 months
Notice to Department of Health Services Inventory & Appraisement	4-8 months



cont...The Probate Timeline

Pay State and Federal Taxes (if necessary)	6-12 months
Allow or Reject Creditor Claims	6-12 months
Possible Preliminary Distributions	6-12 months
Notice to Department of Health Services (if deceased received medical)	6-12 months

Notice to Franchise Tax Board (if heir is out of state)	6-12 months
Claim of Exemption (if assets transfer to a minor)	6-15 months
Receive Final Tax Letter from State and Federal (if appropriate)	6-18 months
File Petition for Final Distribution and Accounting	8-16 months
Hearing on Petition for final Distribution and Accounting	8-16 months



cont...The Probate Timeline

Distribution of Assets to Heirs	9-17 months
Final Discharge Order (indicates close of probate case)	9-18 months
Final Distribution of Funds	9-18 months
